## Terms and Conditions

### CAMPAIGN PERIOD

The campaign period shall be from 1<sup>st</sup> January 2023 to 28<sup>th</sup> February 2023 (both dates inclusive), or such other period(s) as may be determined by Phillip Nova Pte Ltd (“Phillip Nova”) in its absolute discretion (the “Campaign Period”).

### ENTITLEMENT

Receive S\$128 in trading credits for an initial deposit of S\$3,000

### MINIMUM NO-WITHDRAWAL PERIOD

1. There is a minimum no-withdrawal period of 3 months for both the initial deposit and trading credit awarded after receiving the entitlement.

### COLLECTION OF ENTITLEMENT
