## Terms and Conditions

### CAMPAIGN PERIOD

The campaign period will be from 1<sup>st</sup> November 2022 to 31<sup>st</sup> December 2022 (both dates inclusive), or such other period(s) as may be determined by Phillip Nova Pte Ltd (“Phillip Nova”) in its absolute discretion (the “Campaign Period”).

### ENTITLEMENT

1. **New** Phillip Nova customers will be eligible to receive SGD100 (or USD70 for MT5 accounts) when they have **successfully opened a trading account using the campaign code “FIFA2022”, fund a minimum of SGD1,000 and place a trade of any size** with Phillip Nova Pte Ltd (the “Promotion”).
2. Products offered by Phillip Nova Pte Ltd are as follows:

  - b. Exchange-Traded-Funds (ETFs)

### MINIMUM NO-WITHDRAWAL PERIOD

### COLLECTION OF ENTITLEMENT

5. The SGD100 (or USD73 for MT5 account) will be credited into the eligible accounts 2 weeks after the end of the Campaign Period.

## ELIGIBILITY FOR THE PROMOTION

6. To identify new accounts from this campaign, participants must indicate the campaign code “**FIFA2022**” within the account opening form, under the section “**How do you know PNPL?\***”.
7. To be eligible for the promotion, all requirements have to be met within the Campaign Period.
